Port Charlotte, Fla. – NEW LOCATION! The Florida Department of Health in Charlotte County in collaboration with Charlotte County Emergency Management will provide free COVID-19 testing at South County Park starting Wednesday, August 19th.

<u>South County Regional Park</u>: 670 Cooper Street, Punta Gorda, FL Wednesday, August 19th, 9:00 a.m. – 11:00 a.m.

Residents can secure an appointment for testing by registering at: https://coadfl.org

Appointments are required. Individuals must be 18 years and older. No same-day appointments will be made. Walk-ups accepted. Additionally, anti-body testing will not be available.

This is a "drive-thru" service. All individuals must stay in their vehicles during the process (during registration and while being tested). Results may take 7-10 days.

Appointments **NOT** required but recommended. Individuals must be 18 years and older. No same-day appointments will be made. No "walk-ins" accepted. Additionally, anti-body testing will not be available.

- <u>Local Pediatricians</u> **Most** Charlotte County pediatricians do testing for current patients with symptoms/exposure.

<u>Should I be tested for COVID-19?</u> Before you decide to make an appointment to be tested for COVID-19, please consider the following:

- Are you ill, or caring for someone who is ill?
 - o In the two weeks before you felt sick, did you:
 - Have contact with someone diagnosed with COVID-19?
- Do you have any of the following?
 - Fever or feeling feverish (chills, sweating)
 - Cough
 - Sore throat
 - Muscle aches or body aches
 - Vomiting or diarrhea
 - Change in smell or taste
- In the last two weeks have you spent time (visited, worked or volunteered) in a hospital, emergency room, clinic, medical office, long-term care facility or nursing home, ambulance service, first responder services, any health care setting or taken care of patients or someone who has been sick?
- Do you have any of the following conditions?
 - o Chronic lung disease, moderate to severe asthma, or smoking
 - Serious heart conditions
 - Weakened immune system (cancer treatment, prolonged use of steroids, transplant or HIV/AIDS)
 - Severe obesity (Body Mass Index [BMI] greater than or equal to 40)
 - Underlying conditions (diabetes, renal failure, or liver disease)

Please stop the spread of COVID-19:

• If you have been tested for COVID-19, please stay at home until you receive your test results.

- Follow social distancing, even when you are at work and home (especially if someone in your home is sick)
- Stay at home if you are sick, or if you have been around someone who has been sick.
- Wash your hands often with soap and water for at least 20 seconds
- Cover your coughs and sneezes; cough or sneeze into a tissue NOT in your hands!
- Cover your face with a cloth face covering when you are in public or around others.
- Clean and disinfect frequently used surfaces
- Avoid travel to higher risk areas (areas known to have high numbers of cases)

The Florida Department of Health (DOH) releases a report on COVID-19 cases in Florida once per day. There is also a report detailing surveillance data for every Florida county. The Florida Department of Health also releases a list of long-term care facilities in Florida with active cases and number of deaths in each facility.
